C. HEREBY RELEASE, WAIVE, DISCHARGE AND COVENANT NOT TO SUE Bluegrass Pulling Productions as an association including all its corporate, elected and appointed officials, all member of the committees, referees and inspectors, its individual members, its member clubs, agencies of government which control essential land sites, financiers and firms which render essential service gratis, including all officers, and employees of the foregoing and volunteer workers assisting in sanctioned Bluegrass Pulling Productions activities, all hereinafter referred to as "Releases" from or for any and all liability to me, my personal representatives, heirs, next of kin, successors and assigns, for all loss or damage for bodily injury, death or damage to property of the undersigned which in any way grows out of or results from any Bluegrass Pulling Productions event or part thereof during the actual sanction period and whether any such claim may be based upon alleged active or passive negligence whether caused by the releaser or otherwise, or participation in the wrong, or upon and alleged branch of any statutory duty or obligation and

D.
